Our committee sometimes gets referrals from the Answering Service Committee. Members of the public or professional people who deal with alcoholics in their practice will often call the hotline number looking for information or literature from AA. We are then brought in to make personal contact with the caller.

Sometimes we will contact law offices, magistrates' offices, police stations, doctors' offices, libraries, etc. unsolicited and bring AA literature appropriate to the situation if the staff members are agreeable.

We are also at your disposal, AA members of District 23. If you know of a place that is interested in learning more about Alcoholics Anonymous such as your PCP, work place, clergy, community health fair, just let us know.

COMMUNICATION—using the tools that are available to us

Since our inception, AA has relied on technology. In the beginning, members used the telephone, in some sense maybe more so than a lot of other people. It was, and still is, our life-line to other drunks. When we are in a jam and feel like we need a drink, don't our sponsors always tell us to pick up the phone?

As time has gone on, we have come to have more communication tools at our disposal. The internet burst forth for most people in this century, and with the advent of smart phones there are very few people who don't have access to the worldwide web.

Several years ago in District 23 we agreed to spend money on a website. These are your dollars at work, but what concerns me, is that our website is underutilized by our members, nor am I sure that we are availing ourselves of the other websites available to us, including GSO, the Pittsburgh Area Central Office and Area 60.

In reviewing effective ways to communicate with other AA's, I realized that perhaps all the groups and members do not know what communication tools are available to them. With that in mind, I am going to list some of the communication tools that are available to all AA's, and when and how they can and should be used. I'm also going to challenge all the District Committees, home groups and members to use these wonderful tools whenever possible and appropriate.

1.Newsletters

- **A.** The 23 Informer—Group anniversary, picnics, meeting changes and district events should go into the 23 Informer. Articles and personal stories (sharing your experience, strength and hope) can also be submitted. Submissions should be sent to: Monica at editor@aa-swestpa-dist23.org. Submissions must be received the Monday before the GSR meeting.
- **B.** <u>The Pittsburgh Central Office Newsletter</u>—Group anniversary, picnics, meeting changes and district events should go into the Central Office Newsletter. Submissions may be either emailed to: <u>pghareaoff@aol.com</u> or members can call 412-471-7472. Submissions or announcements for the Pittsburgh Central Office Newsletter must be received by the 10th of the month.
 - 1. Why the Pittsburgh Newsletter?—We serve the members of AA as a whole. Even though as groups or individual we may not travel outside our area, many newcomers do! We encourage newcomers to attend events, so it is our responsibility to publish them when we can.
