## **Interested in a service position?**

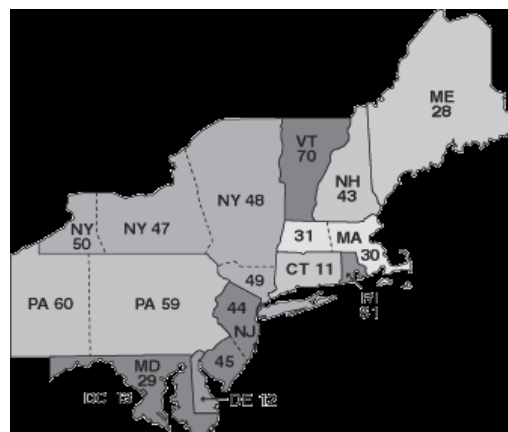
### **H & I service positions available.**
