DCM REPORT

Greetings Fellow AA's:

Our meeting on June 26 will have a serious vote involving our website and whether or not it is prudent to operate our own website when Area 60, and the Central Office websites have many of the same features.

I am hopeful that all the groups had vigorous discussion within their home groups about this issue, and how it affects AA as a whole, not just how it affects our individual home groups.

The group conscience is a very important component of Alcoholics Anonymous. Our second Tradition in the <u>Twelve Steps and Twelve Traditions</u> states: "For our group purpose, there is but one ultimate authority, a loving God as He may express himself in our group conscience. Our leaders are trusted servants, they do not govern."

How does this differ from a majority vote? For one thing, it is the AA tradition to strive for "substantial unanimity." This means that a vote should carry by a two thirds majority. Although some groups may only do this on what is deemed a very important matter, it is pretty much the general rule at district and area meetings.

How do we get to substantial unanimity? As alcoholics, how do we come to most important decisions? Generally, it is through spirituality, prayer, and in the case of the group conscience listen respectfully to all sides of the issues, being willing to admit we may not have all the answers, and listening carefully to the minority opinion, which has been known to often change entire votes but we should remember that as often as the minority vote can be right, it can also be wrong.

The group conscience is truly "principles before personalities" in action.

It is my prayer that everyone is voting from the stand point of an informed group conscience.



Earlier this year I began a new journey in recovery serving as Area 60 Corrections Coordinator (alternate)...As I reviewed the relevant literature my mind began to reflect upon my past consequences at the depths of my active alcoholism. I was an inmate in county jail. Since local AA members were bringing in a meeting I was too ashamed to go and face them. Whenever mail call time came I would become very depressed if no letters came from family. Unbearable

loneliness set in and I isolated. Many alcoholics on the inside experience the same thing and drink the very same day that they are released only to find themselves back in prison again and again...

Unless this relapse cycle is broken many will continue to suffer indefinitely. This does not have to happen. We can each help at the individual, group and district levels. To me this means awareness, willingness and action. Awareness is as simple as having literature available at meetings such as Bridging the Gap, Pre-Release Contact and Corrections Correspondence... I have been to many different meetings in Southwestern Pennsylvania and seem to notice a trend of this literature not displayed at the meetings... If each district were to ask themselves one simple question then this might become less prominent... that question is simply; Is our District being of maximum service to our fellow alcoholics behind prison walls? If the answer is NO or WE DON'T KNOW then please do not hesitate to contact the Area 60 Corrections Coordinator (Ron C.) or myself for assistance.
